Mission Ridge Key Re-Allocation

Keys to Mission Ridge are re-allocated each year at the March WOR meeting. Advanced rated pilots who are interested in becoming Keyholders, and current Keyholders who wish to maintain their Keyholder status, must submit an application package. This package consists of a completed application form, copies of current USHGA and WOR memberships and proof of current vehicle insurance. Note; Your vehicle insurance form must show minimum coverage of \$500,000.00 BI (bodily injury) and \$100,000.00 PD (property damage) per incident.

Completed applications must be received by midnight, February 24, 2008.

Non-renewing Keyholders are asked to notify the site committee chairman of their intentions to help expedite key re-allocation and refund of their key deposit.

Requirements for Key Allocation:

1. 4WD vehicle with minimum rack capacity of 4 hang gliders if applicant is a HG pilot, or 3 hang gliders if applicant is a PG pilot. *The rack system must pass inspection by the site committee. Rack guidelines are on the web at;

- 2. Current vehicle insurance; minimum coverage \$500,000.00 BI / \$100,000.00 PD.
- 3. Fire extinguisher; minimum size 5 lb.
- 4. USHGA and WOR member in good standing throughout keyholder tenure.

Additional decision Criteria for Key Allocation:

- 1. Frequent site usage during preceding year.
- 2. Contribution to club through work parties and/or site/club administration.
- 3. Good record of giving rides to launch.

The key swap will take place at 7:00 PM, just before the March WOR meeting. The selected applicants will be notified prior to the meeting. Please bring either a \$20 cash key deposit or last years key. The locks will be changed that evening.
