Ben Dunn flew 3.5 hours and reached 8000' after launching from the 600' hill at Ed Levin; went as far as Alum Rock. Robert and Mike flew for 2.5 hours at McClure.

There was a public meeting to discuss the plans for public access at Mt Umunum. Photos of flying are sought for Parks and Open Space websites. This could be an opportunity to promote our sport.

Vice President: Karl Allmandinger Nothing to report. Treasurer: Don Herrick Income is exceeding expenses as membership renewals come in.

Flight Director: Pat Denevan

There was an injury at Hollister when a H3 pilot zoomed up before flaring for landing, then stalled and dove in. The pilot was driven to a hospital, where it was discovered that he had suffered a spinal injury. In hindsight, the pilot should have been evacuated by ambulance using a back board, etc. It's better to be more conservative in evaluating an injured pilot. Dave Will mentioned that an accident report should be provided to USHPA. This affects coverage under the USHPA insurance policy. Pat

mentioned that a "high altitude" special skill rating is under consideration. The skill sign-off would cover launching above 6000' MSL.

Membership Services: Phyl Hamby

The HG pilot who crashed on Sunday is OK. A PG pilot crashed in the LZ and was evacuated on a back board. She later stated that she was glad the people on the scene did not let her move. She apparently suffered a back injury. The pay phone in the LZ works for 911 calls without coins.

Phyl is arranging a work party with the Parks Dept. The Parks want WOR to help obtain crushed rock for the road. Phyl also noted that the Parks does not want WOR to make "water bars" on the road. They require that water diversions be built up rather than cut down, a "rolling dip". Eric Froelich noted that the road has been widened in places by people driving around the ruts.

Editors Psychotic Ramblings

This just in... According to an article in the British Medical Journal date 20 Dec 2003, the effectiveness of parachutes to reduce the risk of injury after gravitational challenge has never been proven. "The perception that parachutes are a successful intervention is based largely on anecdotal evidence". The journal found that there has been no "double-blind, randomised, placebo controlled crossover trial of the parachute". It further states that "the major weakness of observational data is the possibility of bias ... which can be obviated largely by using randomised controlled trials. The relevance to parachute use is that individuals jumping from aircraft without the help of a parachute are likely to have a high prevalence of pre-existing psychiatric morbidity. Individuals who use parachutes are likely to have less psychiatric morbidity and may differ in key demographic factors such as income and cigarette use".

The journal notes that "the parachute industry has earned billions of dollars for vast multi-national corporations whose profits depend of belief in the efficacy of their product. One would hardly expect these vast commercial concerns to have the bravery to test their product in the setting of a randomised controlled trial. Moreover, industrysponsored trials are likely to conclude in favour of their commercial product".
