
Meeting Minutes

- [Ben] President's address
 - Lake McClure is open to paragliding! P4 site only. Contact WOR board for information and contacts.
 - Mori Point will be uninsured beginning next year in March of 2023. Details later in the meeting
- [Tristan] Treasurer's report
 - New fiscal year: Oct 1 to Sep 30.
 - \$38,241 in the bank, +34% from 2021.
 - \$9,864 operating income, -12% from 2021.
 - Expenses up due to: The Stables & Mori Point permit fees, Ed Levin lawn mower purchase, FFFA workshop
 - Expect big increase in insurance fees in 2023.






Number of members by wing type:



- [Ben] Mori point update
 - Insurance costs are drastically increasing next year, and Mori Point is only flown 2 or 3 times per year.
 - Board vote results and decision:
 Abandon Mori Point after the next insurance renewal?
 - Yea 6
 - Nay 1
 - Decision: We will not renew our insurance for Mori point in March, 2023. Our permit with the GGNRA extends into 2024, so we have the option to reinsure the site if anything changes.

 - New Ed Levin Chair starting today: Clemence Lepold
 - SCCPD electronic waivers are now hosted on the club website.
 - o [Steve] Mission
 - A big Thank You! to our Mission Site Committee + Intro Teams for sponsoring an extended set of pilots to access the Mission Site
 - The park has granted us permission to install a webcam and weather station atop the windsock. We need volunteers to select, procure, and install the equipment. It must be battery and solar powered as there is no power available.
 - Lease agreement between City of Fremont and EBRPD under review right now. No significant changes for us if the current version passes, which is good news for us.

Editorial December 2022

November had many good days for free-flight at Wings of Rogallo sites and business took place as usual for end-of-year items like elections and the annual meeting. The first day of the month brought the first serious rain to the Bay Area for the season. Mission and Ed Levin got all the love in November resulting in very packed days but the more the merrier according to all reports.

The first half of the month was wildly successful for Mission Peak. 11/3 had a scrappy paraglider flight in leeside thermals. 11/4 had a great turnout with 30 min extended sledders. 11/5 hosted some hike and fly. 11/6 was a big Mission day with strong wind and lots of paragliders and hang gliders. 11/9 was paraglider-launchable but strong. 11/12 had some good flying with some cross country to Evergreen with a report of 'Mission Magic at 4:30 PM and 20 of each paragliders and hang gliders. 11/13 was another nice Mission day. 11/14 Mission paid off on the back launch with a climb to 2,283 feet MSL. 11/26 had more backside launches at Mission.

Ed Levin is another site that shines bright in the cold rainy days of the Winter. 11/7 a paraglider made it up from 600 and reported it was colder and not as smooth as the day before, and that the 600 was barely blowing in but the air was breezy up higher. There were nice organized cumulous clouds. 11/12 was a flying day. 11/13 was a fun day at the 600 with kooky cycles, dust devils and the

windsock doing 360s and aiming straight up at times.

11/18 gliders were spotted in LZ. 11/19 Ed Levin was
working but Mission wasn't due to East winds. 11/24 was a
fun day at Ed Levin with extended sledders over the 1,200
foot launch. 11/25 was a buoyant day with paragliders and
hang gliders, a scorpion spotted at the 300, mostly
sledders and one top landing. 11/26 was a good day at Ed
Levin with backside launch but not long flights. 11/27 was
another over the back day but a 10 minute cycle up the
front for allowed two hang gliders to take advantage.

11/30 was good wind for many hang glider pilots with four
making it to the Peak at Calaveras Lake.


